

- Survey carried out by YouGov 18th 20th October 2023.
- Survey responses are from just under 1000 UK Parents/guardians with children aged between 5 and 18 years old
- All figures, unless otherwise stated, are from YouGov Plc. Total sample size was 4,317 adults, of whom 928 were parents of 5-18 year olds. Fieldwork was undertaken between 18th 20th October 2023. The survey was carried out online. The figures have been weighted and are representative of all UK adults (aged 18+).





A further look at the data from this question suggests support is very strong for schools' role in RSE amongst parents/guardians of primary aged children:


When answers to RSE question 4 are filtered to only include the 509 respondents who are parents/guardian of 5-11 year olds, 86.5% agree that "Schools should have a role, alongside parents and/carers, in teaching children and young people facts about relationships and sex" vs 86.6% who agreed from the overall sample of parents of 5-18 year olds.

Also that parents who are consulted by schools are significantly more supportive of schools' role in "teaching children and young people facts about relationships and sex":

When answers to RSE question 4 are filtered to only include the 374 respondents to Q5 that did feel consulted, 95% agree that "Schools should have a role, alongside parents and/carers, in teaching children and young people facts about relationships and sex"


When answers to RSE question 4 are filtered to only include the 454 respondents to Q5 that did **not** feel consulted, 85% agree that "Schools should have a role, alongside parents and/carers, in teaching children and young people facts about relationships and sex" – a 10% difference






